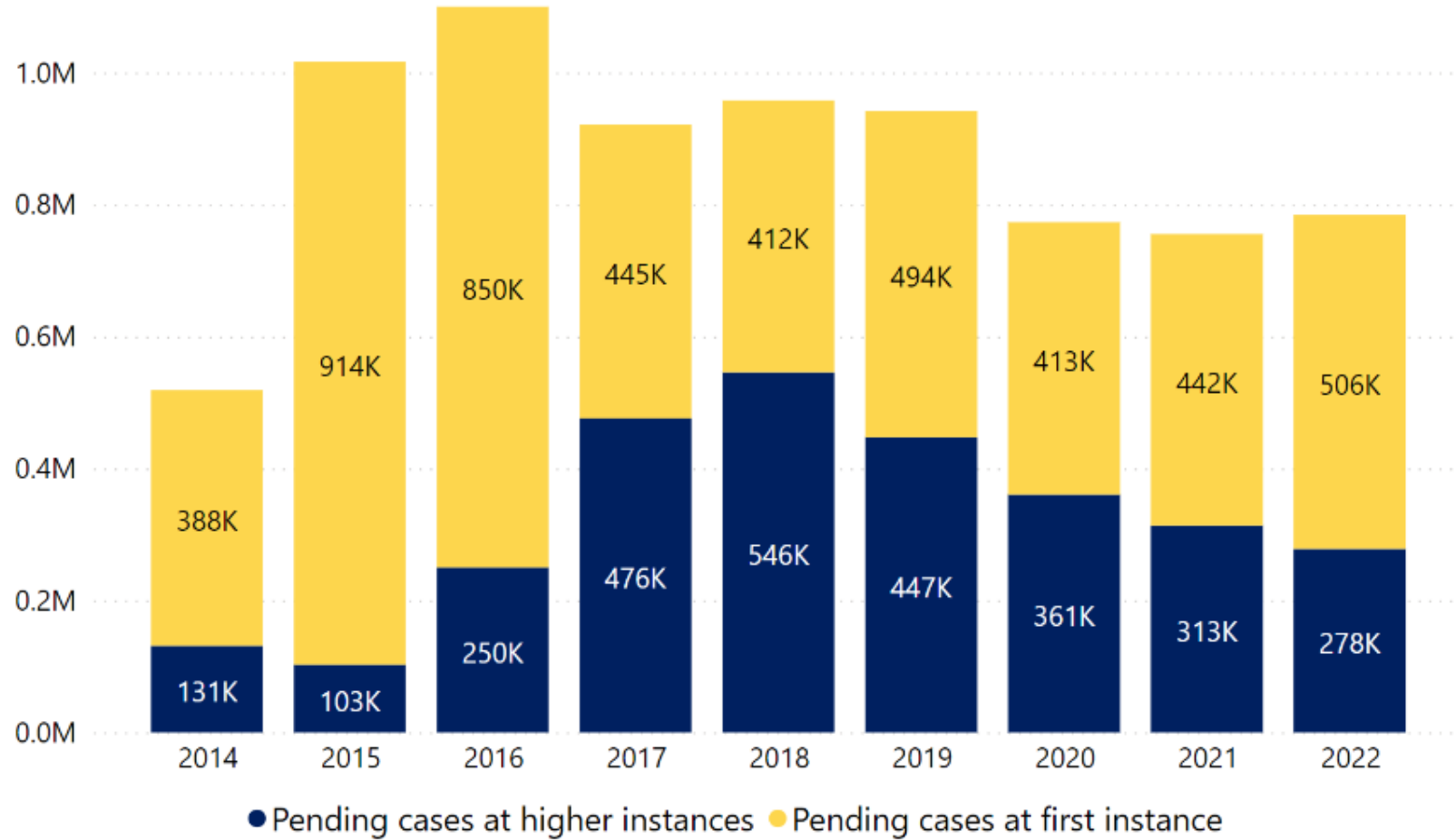

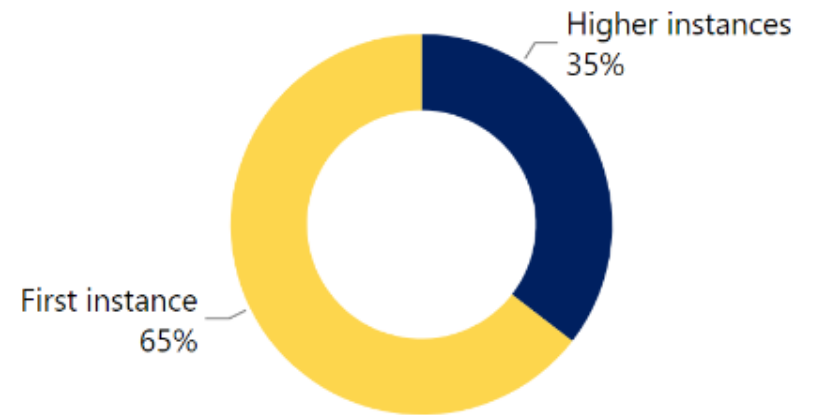
# Pending cases at higher instances

Pending cases in EU+ countries at the end of each year, 2014-2022

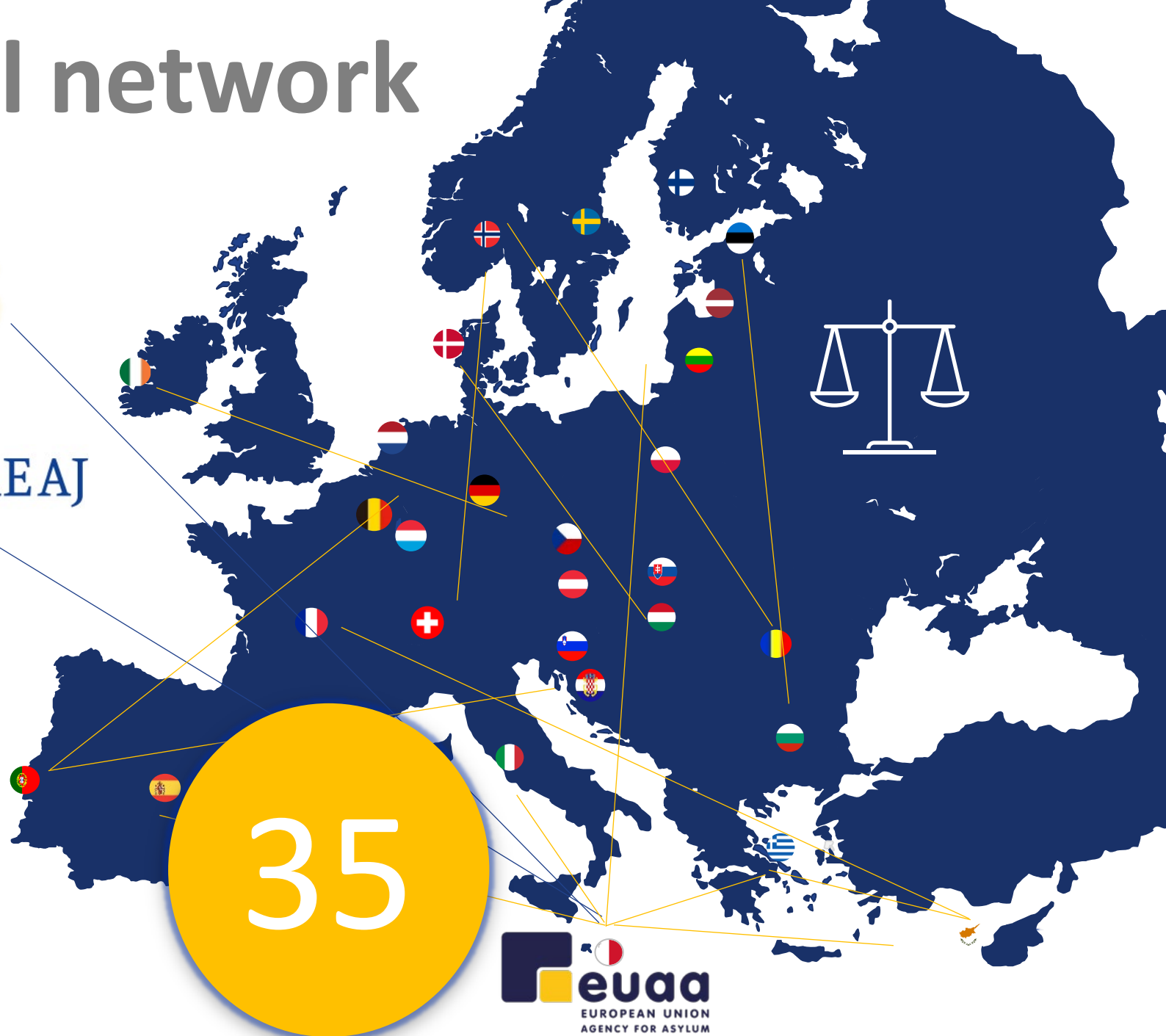


Pending cases - May 2022
